Quality Assurance Report Tester

Position summary:

Conducts development and/or format Quality Assurance (QA) reviews of all Business Objects documents, application documentation, website content, training materials and System Development Life Cycle (SDLC) artifacts to ensure they are developed using established standards across multiple business lines areas. Provide additional ad-hoc development support in creating new documents or modifying existing documents on an as needed basis.

Position Tasks:

- Reviews and maintains all reports, ad-hoc queries to enforce adherence to formatting standards that provide real-time business information to all levels of personnel through mission critical documents and reports and on-line applications using Business Objects and/or Crystal Reports.
- Develops and execute test scripts as well as document detailed expected results, including scripts for functional, regression, performance, system and user acceptance tests using manual and automated procedures.
- Verify all test results to ensure the system is performing functions as described in the business requirements and design documents.
- Write detailed and accurate problem and defect reports, where applicable.
- Conduct metric collection and analysis.
- Collaborates with the Project Management group to ensure appropriate quality assurance information is updated and distributed to the necessary stakeholders.
- Review application documentation, website content, training materials and SDLC artifacts to ensure the highest level of quality.

Required Skills Sets:

- Minimum two (2) years experience working with Business Objects and/or Crystal Reports in a data warehousing environment, demonstrating skills in developing and troubleshooting ad-hoc reporting to meet specified business information needs.
- Proven experience of excellent organization skills, with an attention to detail in the development and maintenance of documentation regarding testing plans and its related review and enforcement of corporate standards, policies and guidelines.
- Familiarity of the System Development Life Cycle (SDLC) process as it applies to quality assurance artifacts, processes and activities.
- Experience working with defect tracking tools.
